Investment Objective -



Particulars	Description
Investment objective	Generate capital appreciation over long term by investing in Equity and Equity related instruments
Description of securities	Client's funds shall primarily be invested in mutual funds and ETFs investing in equity and equity related instruments. Some part of funds might be invested liquid or ultrashort funds/ liquid ETFs or units of money market instruments or might be retained as bank balance in bank account.
Basis of selection of securities	Mutual Fund and ETF selection takes place based on the consistency of returns and personal experience of the portfolio manager in the capital markets. Securities with high return and risk-reward are selected by taking long positions.
